BIDDERS TO NOTE THE FOLLOWING:

The Mthonjaneni Municipality Supply Chain Management Policy will be applied and the Bids will be evaluated in terms of the 90/10 point system. Failure to complete all Bid forms, data sheets and submit all supplementary information may render the Bid to be considered as non-responsive and therefore may not be considered for the award of the contract. All Bids submitted should remain valid for 90 days after the Bid closing date.

Sealed Bid documents bearing the project name and Bid number " **UPGRADE OF RURAL ROADS IN MTHONJANENI PHASE 2**" must be deposited in the Tender Box of Mthonjaneni Municipality. Telegraphic, telephonic, telefax, facsimile, emailed and late Bids will not be accepted.

The evaluation of the Bid will be conducted in two stages:

First stage, the assessment of the functionality will be done in terms of the evaluation criteria and the minimum threshold.

Second stage, the bids that meet minimum threshold will then be evaluated in terms of 90/10 preference point system, where 90 points is for price, and 10 points is for BBBEE status level of contribution.
